What is Alpiq Group's management structure?

Who is Alpiq?

Alpiq is an independent electricity producer and energy trader. The company is active in the business fields of energy generation, trading, and services. Its customers include medium-sized companies, large enterprises and public institutions.

Who owns Alpiq?

The canton of Solothurn sold its shares in Alpiq during the reporting year. The three shareholder groups EOS Holding SA, Schweizer Kraftwerksbeteiligungs-AG and the consortium of Swiss minority shareholders each hold one-third of the Alpiq shares. Alpiq Energy SE is a major energy trading firm based in Switzerland. It is active as one of the largest cross-border energy traders in Central Eastern and South Eastern Europe and a key international player with a growing gas portfolio.

Alpiq is located in the Czech Republic. The company operates its Shared Service Centre, Alpiq Services CZ s.r.o., in Prague. Here, it has established a high level of expertise in the core processes of energy trading, such as middle office, scheduling, and risk management.

Alpiq Finland Oy is the Finnish subsidiary of the Alpiq Group. It offers origination products and services for the Nordic/Baltic market from its offices in Finland. Alpiq Finland Oy is the entity responsible for the portfolio of services including: PPAs, long-term supply, flow deals, physical balancing, and other structured origination products.

In the 2022 financial year, the Alpiq Group generated net revenues before exceptional items of CHF 14.9 billion (up CHF 7.2 billion on the previous year) and an EBITDA before exceptional items of CHF 473 million (up CHF 161 million). The Swiss power production contributed a stable result despite lower inflows into the reservoirs.
