What is Kosovo's Energy Strategy?

The energy strategy foresees 170 MW in battery operating power. In addition, procedures are scheduled to be announced in the fourth quarter for a solar power plant of 100 MW for government-controlled power utility Kosovo Energy Corp. (KEK) and a solar thermal system for district heating in Prishtina, according to Rizvanolli.

Does Kosovo have a power exchange with Albania?

After the agreement between KOSTT - ENTSO-E, Kosovo made a joint with Albania and the 400 kV interconnection known as "Energy Highway" (or in Albanian "Autostrada Energjetike"), which was finished in 2016, but it was enabled in 2020, opening the way for the establishment of a joint power exchange between Kosovo and Albania.

What are the power plants in Kosovo?

The greatest part of generation capacities of Kosovo are the two power plants: Kosova A and Kosova B. The capacities of the two power plants are lower than the installation parameters level, because of the outdated system and lack of maintenance during the last decade of the 20th century.

Does Kosovo need a new energy sector?

Given this background, the Government of Kosovo has prioritized the modernization and improvement of the country's energy sector, and has asked its development partners, including the World Bank, European Commission, KfW, USAID, as well as other donors, for support and assistance.

How much solar power does Kosovo have?

With regard to solar power, Kosovo's installed capacity at the end of 2020 stood at 20,9MW, the bulk of which are sited at agricultural facilities throughout the country. However, a few recently announced solar power projects are poised to increase that number significantly.⁹

Is battery storage the lowest cost option in Kosovo?

As such, batteries can be an important complement to a power system dominated by variable renewables; however, as the graph above shows, battery storage may not necessarily be the lowest cost option in Kosovo's context, particularly if greater access to supply from neighboring jurisdictions can be secured through expanded grid interconnection.
