Why did Centrica buy British Energy?

In May 2009, Centrica purchased a 20% stake in nuclear power generator British Energy from EDF Energy. The company now produces 14.3% of its electricity from nuclear plants (the second highest rate in the United Kingdom), helping it to achieve the lowest carbon emissions of the major providers.

How does Ghana generate electricity?
