ENERGY USE PATTERNS IN NEPAL. Use of cogeneration energy: biomass. The pattern of energy use in Nepal is dominated by the use of traditional energy sources (biomass) for household consumption. In 2005, energy use was estimated to be 87.7% from biomass energy sources and 12.3% from commercial energy sources (Figure 1).
