Why is energy important for Ethiopia?

Energy is one of the most significant sectors for Ethiopia's economic growth and development and is expected to increase significantly in the medium run. Ethiopia has abundant renewable energy resources and the potential to generate over 60,000 megawatts (MW) of electric power from hydroelectric, wind, solar, and geothermal sources.

How much does hydropower cost in Egypt and Ethiopia?

Costing hydropower: We used electricity prices for businesses in Egypt and Ethiopia to calculate the economic gain or loss of hydropower. The electricity prices per kWh for businesses in both countries are nearly the same at 0.022 USD for Ethiopia and 0.024 USD for Egypt.
