Will new fortress energy build a new LNG import terminal in Sri Lanka?

New York-based gas-to-power developer New Fortress Energy has signed a framework agreement with Sri Lanka's government to construct a new offshore LNG receiving, storage and regasification terminal. The LNG import terminal is to introduce LNG to Sri Lanka for the first time in order to push the country's transition to cleaner energy sources.

Why is Sri Lanka partnering with new fortress energy?

"This is a significant milestone for Sri Lanka's transition to cleaner fuels and more reliable, affordable power," said Wes Edens, Chairman and CEO of New Fortress Energy. "We are pleased to partner with Sri Lanka by investing in modern energy infrastructure that will support sustainable economic development and environmental gains."

Which LNG terminal will supply power plants in Sri Lanka?

The new LNG terminal off the coast of Colombo will supply gas to the power plants in the country. New Fortress Energy (NFE) has reached an agreement to build a new offshore liquefied natural gas (LNG) receiving, storage and regasification terminal in Sri Lanka. A related framework agreement has been signed with the Government of Sri Lanka.

Will new fortress supply LNG to Yugadanavi Power Plant?

Under the agreement, New Fortress will supply LNG to the existing 300 megawatts Yugadanavi power plant. NFE is negotiating the purchase of the government's 40 per cent stake in the company that owns the power plant.

Will Sri Lanka's first LNG terminal be a good investment?

Wes Edens, chairman and CEO of New Fortress Energy, said: "This investment in Sri Lanka's first LNG terminal will advance the country's clean energy transition and support sustainable development for this vibrant economy. This is the first of what we think will be a number of investments in power and infrastructure in the country."

Does new fortress have gas supply rights to Kerawalapitya power complex?

As part of the transaction, New Fortress will have gas supply rights to the Kerawalapitya Power Complex, where 310 MW of power is operational today and an additional 700 MW scheduled to be built, of which 350 MW is scheduled to be operational by 2023.
