Why did GCL change its name to GCL Technology Holdings Limited?

On February 21,GCL-Poly Energy Holdings Limited announced a proposal from its Board of Directors,according to which the company is to change its name from "GCL-Poly Energy Holdings Limited " to "GCL Technology Holdings Limited ",in accordance with its future strategic focus on silicon materials technology and technology innovation.

Is GCL Poly A Chinese company?

As of 2009 it was the largest supplier of polysilicon in China,and is also a supplier of electronic wafers for the solar industry. GCL-Poly listed at the Hong Kong Stock Exchange in 2007.

Who owns GCL-Poly?

In November 2009, China Investment Corporation (CIC) bought a HK\$5.5 billion (\$710 million) minority stake in GCL-Poly. February 14, 2014 GCL-Poly implement Subscription Rosenthal Group 360,000,000 new shares at a price of four yuan per share, a discount of 70.37% compared with before the suspension.

Who is GCL New Energy Holdings Limited (0451)?

Listed on the Hong Kong Exchange in 2014,GCL New Energy Holdings Limited (0451. HK) (GCL New Energy) is a new energy company under GCL Group. Its primary business is solar power generation,covering development,construction and operations.

Is GCL-Poly A national high-tech company?

GCL-Poly's nine subsidiaries including Jiangsu Zhongneng,GCL Silicon Materials,GCL Ningxia,GCL Suzhou,and GCL Henan etc. are all listed as China's "National High-tech Enterprises".

When did GCL-Poly IPO?

GCL-Poly listed at the Hong Kong Stock Exchange in 2007. The IPO price range was 3.3 to HK \$4.1,raising up to 1.181 billion yuan. In November 2009,China Investment Corporation (CIC) bought a HK\$5.5 billion (\$710 million) minority stake in GCL-Poly.
