3 ???· About Amplitude Energy. Amplitude Energy Limited engages in exploration, development, and production of natural gas and low-cost oil in Australia. Cooper Energy Limited and changed its name to Amplitude Energy Limited in November 2024. The company was incorporated in 2001 and is headquartered in Adelaide, Australia.

Cooper Energy was listed on the ASX on 13 March 2002 and holds acreage in the Gippsland, Otway and Cooper/Eromanga Basins. In the Gippsland Basin, the company holds eight offshore blocks as well as the onshore Orbost Gas Processing Plant. Cooper holds both onshore and offshore acreage in the Otway Basin, including the Athena Gas Processing Plant.

Cooper Energy has found gas 9km offshore Victoria, Australia, which the company claims is the first new Otway Basin gas field discovery from offshore drilling in 11 years.. Annie-1 is the first offshore gas exploration well that Cooper has drilled in Australia and the initial well of an \$80m drill campaign with a subsidiary of Japan's Mitsui Group.

Strong energy dependence linked to the metallurgical sector. New Caledonia's energy mix is 97.7% fossil fuel, including 54.1% petroleum products (mainly fuel oil and diesel), 43.6% coal, and 2.3% renewable energies. This high energy dependence is directly linked to the metallurgical industry which consumes 61.2% of the total energy consumption of the territory.
