In January 2021, Technip Energies CEO Arnaud Pierson announced plans for an initial public offering and committed to demonstrate to shareholders that the organization could operate independently of TechnipFMC. The TechnipFMC split became effective the following month. The spinoff was completed on 12 February 2021.
