Is Saudi Arabia a regional or middle power?

Saudi Arabia is considered both a regional and middle power. Since petroleum was discovered in the country in 1938, the kingdom has become the world's third-largest oil producer and leading oil exporter, controlling the world's second-largest oil reserves and the sixth-largest gas reserves.

What is the government like in Saudi Arabia?

The government is dominated by the vast royal family, the Al Saud, which has often been divided by internal disputes and into factions. The members of the family are the principal political actors allowed by the government. Political participation outside the royal family is limited.

How much power does Saudi Arabia need?

Saudi Arabia has established a goal to source at least 50 percent of its power from renewable energy by 2030, expanding its capacity to 130 gigawatts (GW), 58.7 GW of which is expected to come from solar and 40 GW from wind. This target is the most ambitious of its kind among Gulf Cooperation Council (GCC) countries (Figure 1).

Is Saudi Arabia an absolute monarchy?

Saudi Arabia is an absolute monarchy; however, according to the Basic Law of Saudi Arabia adopted by royal decree in 1992, the king must comply with Sharia (Islamic law) and the Quran, while the Quran and the Sunnah (the traditions of Muhammad) are declared to be the country's constitution.

The transfer of power was endorsed by Saudi Arabia's ulama, or religious authorities. King Faisal strengthened the powers of the monarchy during his eleven-year reign. Although he had acted as prime minister during most of Saud's rule, he issued a royal decree stipulating that the king would serve both as head of state and as head of government

The politics of Saudi Arabia takes place in the context of a unitary absolute monarchy, along traditional Islamist lines, where the King is both the head of state and government decisions are, to a large extent, made on the basis of consultation among the King, the Council of Ministers, Islamic scholars (until the mid-2010s), tribal leaders, and other traditional elites of the society.
