



Is Acciona Energia ready for a flotation?

The Spanish Securities and Exchange Commission (CNMV) today approved the registration document for the initial public offering (IPO) of ACCIONA Energia, a leading company in the generation of 100% renewable energy, as a preliminary step towards its flotation.

What did Acciona Energia do in the first half?

ACCIONA Energia, a leading company in 100% renewable energy generation, closed the first half of the year with a EUR153 million attributable net profit (+91.4%).
