Who is sunseap energy?

Who is sunseap leasing?

Sunseap Leasing is the first and largest solar leasing company in Singapore. Sunseap International targets markets in the South East Asian and Pacific regions. These include a 168 MegaWatt-peak (MWp) solar farm in Vietnam, a 140 MWp solar farm in India, and a 10 MWp solar farm in Cambodia.

Will sunseap provide electricity to Singapore?

Sunseap has also signed a memorandum of understanding along with a consortium of companies to develop solar power systems in the neighbouring Riau islands of Indonesia to provide electricity to Singapore. These systems will have a combined 7 gigawatt-peak (GWp) capacity.

Why did EDPR acquire sunseap?

The acquisition gives EDPR access to the Asian company's portfolio of roughly 10 GW of solar projects under development across Asia. Apart from Singapore, Sunseap operates in Vietnam, Cambodia, China, Taiwan, Japan, Thailand and Malaysia.

Is sunseap a floating solar project?

However, Sunseap's will be one of the first and largest to be located on the sea. Although Singapore is already a hub of floating solar technology with the world's largest floating PV test-bed at Tengeh Reservoir, it also lacks land, rooftop space and freshwater availability, hence Sunseap's venture out to salt water.

Solar developers Quantum Power Asia and ib vogt are planning to construct a 3.5GW PV plant and 12GWh energy storage facility in Indonesia that will export electricity to Singapore via a subsea cable.

Sunseap's 5MW PV system is expected to be ready by October 2017. Once completed, the installation will be able to generate up to 6.2GW of PV energy per year and help ST Kinetics cut down its ...
