State v. Alonzo, 940 P.2d 1224 (Utah 1997). On certiorari we review the court of appeals' decision, not that of the trial court, and use the same standard of review applied by the court of appeals. Hebertson v. Willowcreek Plaza, 923 P.2d 1389, 1392 (Utah 1996). We review each of the court of appeals' holdings as follows:

State v. Osterloh, 275 N.W.2d 578, 580 (Minn. 1978). "Minnesota courts therefore do not have inherent authority to impose terms or conditions of sentences for criminal acts and must act within the limits of their statutory authority when imposing sentences." State v. Pugh, 753 N.W.2d 308, 311 (Minn. App. 2008), review denied (Minn. Sept. 23, 2008).

People v Alonzo, 62 AD3d 720, affirmed. Janet DiFiore, District Attorney, White Plains ( Raffaelina Gianfrancesco, Lois Cullen Valerio and Anthony J. Servino of counsel), for appellant. Counts two and five of the indictment charging separate and distinct acts of sexual abuse were improperly dismissed as multiplicitous.
